DAVID ARONBERG, State Attorney for the Fifteenth Judicial Circuit, Palm Beach County, Florida, by and through his undersigned Assistant State Attorney, charges that:


COUNT 1: JUAN PABLO PARRA on or about April 30, 2018, in the County of Palm Beach and State of Florida, did unlawfully attempt to commit SEXUAL BATTERY, an offense prohibited by law, and in such attempt did an act toward the commission of such offense and did commit sexual battery upon [REDACTED] a person 18 years of age or older, without [REDACTED]'S consent, by touching the clitoris of [REDACTED] and in the process thereof did not use physical force and violence likely to cause serious personal injury, but JUAN PABLO PARRA failed in the perpetration or was intercepted or prevented in the execution of said offense, contrary to Florida Statute 794.011(5)(b) and 777.04(1). (2 DEG FEL)

COUNT 2: JUAN PABLO PARRA on or about March 31, 2018, in the County of Palm Beach and State of Florida, did actually and intentionally touch or strike L.N. against the will of L.N. {or} did intentionally cause bodily harm to L.N., contrary to Florida Statute 784.03(1). (1 DEG MISD)




