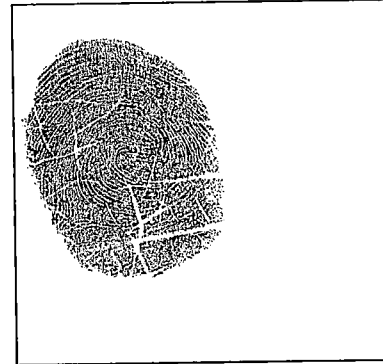

Before me the undersigned Judge of the Fourth Judicial Circuit, in and for Duval County, Florida, personally came Detective D.L. McLennon 76099 who, being duly sworn deposes and says that she has reason to believe and does believe that one **Paul Brady Dyal**, described as follows: Last Known Address: **6350 Old Kings Road, Jacksonville, Florida 32254** Race **White**; Sex: **Male**; DOB: **08/28/1943**; Ht: **5'10"**; Wt: **300** pounds; Hair: **Salt & Pepper**; Eyes: **Blue** ; Scars, Marks: **N/A** did in Duval County, Florida, between March 22, 1979 and March 22, 1983 commit the crime(s) of **Capital Sexual Battery**, contrary to the provisions of Section(s) **794.011 (2)**, Florida Statutes. Affiant's reasons for so believing are as follows:

Your affiant has been employed with the Jacksonville Sheriff's Office as a Police Officer for six (6) years and is currently assigned to the Special Assault Unit. Your affiant has been handling Special Assault cases for three (3) years.

On September 16, 2020, the Jacksonville Sheriff's Office was notified of multiple sexual battery and child abuse incidents that occurred involving suspects and victims affiliated with a church called The Jacksonville Assembly of the Body of Christ (hereinafter the "Church") located at 6350 Old Kings Road, Jacksonville, Florida 32254 (Prior to 1995, the Church was originally located at 6858 Old Kings Road, Jacksonville, Florida 32254). The sexual battery incidents occurred during several years that spanned from 1976 to 2001. The current head pastor of the Church is Paul Brady Dyal (hereinafter the "suspect"), who was also head pastor during this time frame.

During the preliminary investigation, it was discovered that on June 11, 2019, the law firm of Cohen, Milstein, Sellers, and Toll, PLLC sent a demand letter to the Church and to the suspect individually. The letter was on behalf of several victims who disclosed sexual, physical, and emotional abuse that occurred within the Church when they were minor children. The law firm received no response from the Church.

One of the child victims, [REDACTED] now [REDACTED] years old, [REDACTED] years old during the time of the incidents) disclosed that she was sexually battered multiple times by the suspect (DOB 08/28/1943, now seventy-eight years old, thirty-six to forty-three years old during the time of the incidents).

Further research revealed that on August 13, 2003, [REDACTED] reported the sexual battery incidents to the Jacksonville Sheriff's Office (2003-711421). The report was received via a tele serve report and documented that [REDACTED] disclosed that at the age of [REDACTED] she was sexually abused by the suspect when [REDACTED]. The suspect entered the bathroom while [REDACTED] was bathing and fondled her vagina with his hands and a belt

buckle. [REDACTED] made attempts to tell [REDACTED] however, they refused to listen. There was no follow up on this report.

On September 17, 2020, a Detective with the Special Assault Unit interviewed [REDACTED]. She explained that [REDACTED] she joined the suspect's Church when she was approximately [REDACTED] years old. When [REDACTED] was [REDACTED] years old, the suspect first sexually abused her. The abuse continued for seven (7) years. The suspect oversaw the Church during the time frame when the sexual abuse occurred.

[REDACTED] disclosed during the 2020 interview that when [REDACTED] was [REDACTED] years old, the suspect would bathe her at his house. His home was located above the church at that time. [REDACTED] would always go to his home while [REDACTED] were out of town. The suspect would put his finger over his mouth to tell [REDACTED] to be quiet before doing any of the sexual abuse. The suspect would tell [REDACTED] "Be still and do not make a noise." The suspect would then take his belt off and insert the belt buckle into her vagina. The suspect would masturbate himself while sticking his belt buckle up [REDACTED] vagina.

The suspect then started inserting his fingers in [REDACTED] vagina when she was at his home again, when [REDACTED] were out of town. The suspect put his finger over his mouth to tell her to be quiet before inserting his fingers into her vagina. The suspect would sometimes sit on the toilet, pull her close to him, and put his fingers in her vagina. The suspect masturbated himself while he was digitally penetrating [REDACTED] vagina. This occurred at least twenty to thirty times over seven (7) years.

The suspect's wife and two (2) children were in the next room when [REDACTED] was being sexually abused. [REDACTED] stated that she was old enough at the time to bathe herself and she would bathe herself at home, however the suspect insisted on bathing her. The sexual abuse continued until she was [REDACTED] years old for a total of seven (7) years. [REDACTED] articulated that due to the frequency and ongoing nature of these acts, she knew it would happen and would do whatever was necessary to get it over with.

On March 2, 2022, your affiant met with [REDACTED] for an in-person interview. [REDACTED] confirmed that [REDACTED] joined the suspect's Church when she was approximately [REDACTED] years old. [REDACTED] confirmed that the sexual abuse from the suspect started when she was [REDACTED] years old. [REDACTED] were routinely sent away to other churches and when they were out of town, [REDACTED] remembered the first sexual battery incident when [REDACTED] confirmed that the suspect would bathe her at [REDACTED] years old and at the start of the first sexual battery incident. The suspect put his finger over his mouth to tell [REDACTED] to be quiet. This is when Paul inserted a belt buckle into [REDACTED] vagina and [REDACTED] stated, "yes that was first." [REDACTED] advised that she was standing next to the suspect while he was sitting on the toilet, and he had the belt buckle inserted into her vagina and he was masturbating himself.

It was after the sexual battery in the bath with the suspect that [REDACTED] rubbed a lot of soap on her face, and it turned into white suds. [REDACTED] stated she never felt clean after the sexual abuse incidents and left the soap on her face. [REDACTED] demonstrated with her hands by rubbing the palms together as if a bar of soap was between them. She placed both of her hands on either side of her face on her cheeks to indicate where she put the soap on her face. [REDACTED] confirmed that the suspect would digitally penetrate her vagina with his fingers as he bathed her. She also confirmed that the sexual abuse incidents occurred twenty to thirty times over a span of seven (7) years. [REDACTED] felt happy when new girls would come to the Church because she believed she would endure less sexual abuse. [REDACTED] suffered physical abuse by

the suspect, and she recalls always having bruises on her body. [redacted] advised that the sexual abuse lessened when more and more girls entered the Church and from then on, [redacted] would get beatings from the suspect until she was approximately [redacted] years old.

[redacted] stated that [redacted] was employed as the [redacted] at the time of her abuse. She recalled that their sole source of income was from his job. [redacted] recalled that [redacted] was aware of the physical abuse that was being committed on [redacted]. She recalled times that the suspect would withhold payment of [redacted] salary and articulated that this was to maintain control of [redacted] and prevent him from reporting abuses on Church property. [redacted] believed that [redacted] later became aware of the sexual abuse committed by the suspect, but he never reported such abuse.

The suspect was over the age of eighteen (18) at all relevant times. The victim was under the age of twelve (12) during the relevant period of time for the charge associated with this arrest warrant.

The incidents occurred in Duval County, Florida. Although the suspect was clearly known to [redacted] a photo of Paul Brady Dyal was shown to [redacted] to confirm his identity. [redacted] positively identified the suspect.

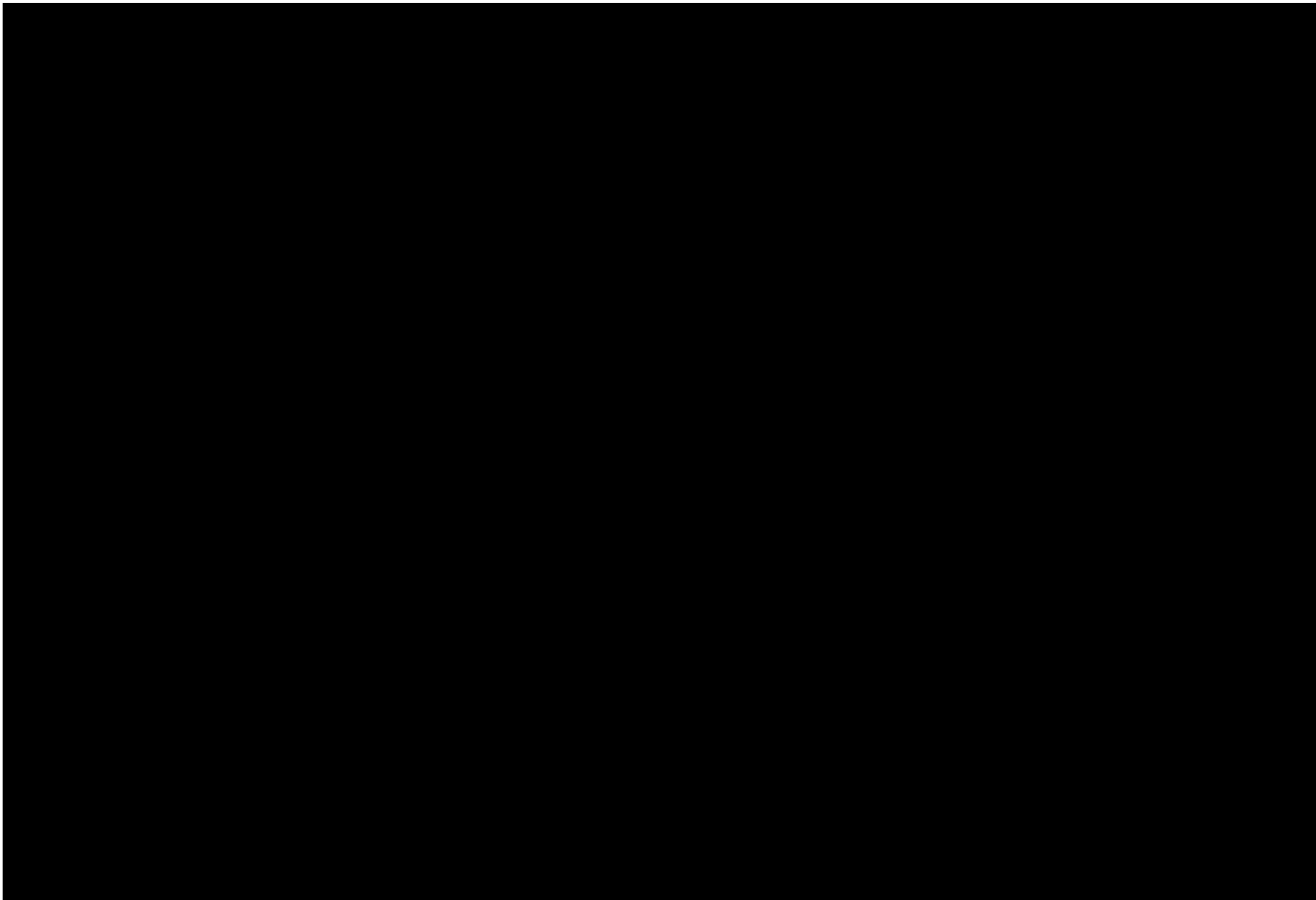
